## EC telecon - 2013-07-11

Called to order at 12:05 pm EDT

- WInSAR funding Chuck gave an update on the current funding status for WInSAR activities and plans for the future. Main points:
  - The current funding by NSF/NASA for supersites will run out in the fall.
  - The GAGE proposal will soon kick in. It has a small component for WInSAR operation, but the GAGE proposal has been cut 23%, so it is unclear exactly what can be supported certainly not at the level in the GAGE proposal.
  - In order to maintain the same level of activity we need to raise ~\$150K a year for a software engineer and technician to task satellites and update supersites, as well as travel money for WInSAR representative/s to attend meetings and engage space agencies to contribute data.
  - In the long run (~ a year), WInSAR should submit a NSF and/or NASA proposal to raise that amount.
  - In the past, NASA has provided about \$50k/year for support, but getting another increment this size seems unlikely
  - There is a need to contact NSF program managers to find a solution this may happen during Chuck's visit to DC on July 29
- NGA SAR data Franz suggested to contact NGA and check to see if they are willing to share their SAR data, as they did with optical data. As Franz has a project with NGA, he will use his contacts there to check this possibility.

- TSX quota and tasking – Main points:

- Scott asked how to resolve tasking conflicts between WInSAR requests (conflicting track/beam in same area). Suggested solution: WInSAR should flag such problem and notify the involving parties, who should seek a solution suitable for both. If cannot find a solution, the problem will be resolved by the EC.
- There is a need to notify John Bell about possible conflict with his tasking requests.
- The new three background tasking requests presented in the agenda were approved.
- There is a need to add more text in the WInSAR page about TSX tasking request evaluations. Requests will be evaluated during semi-annual EC meeting except high priority request (e.g., emergency response or during the summer season) that should treated much faster.

- Action items from last meeting were mostly done - those remaining are still on the list

of action items.

- Franz informed the EC of the possibility to order ALOS-1 data outside the Americas by requesting the data from NASA. Most requests have been approved.
- Meetings Shimon will attend ESA's Living Planet meeting and may give an oral or poster WInSAR presentation. No member of the EC has plans to attend ALOS-2 meeting yet.
- Out reach material on WInSAR (presentations, posters) is available on the WInSAR webpage, but it needs an update.

Action items:

- Franz: Contact NGA to determine who we might contact about access to SAR data
- Chuck: Before the July 29 meeting, talk with Matt and others about developing a "white paper" describing the WInSAR needs that cannot be met with existing resources
- Scott? Notify those who have requested tasking that their tasking requests are approved
- Chris: 1) Find out how many ALOS-2 proposal he is signed up for and which include requests for ALOS-1 and JERS data. Send list to Matt who will then write to JAXA about storing this data at UNAVCO
  - 2) Update EC on the need to write WInSAR annual reports to NSF
- Falk: Will write to JAXA to see if ALOS-1/JERS data acquired through PI ALOS-2 proposal can be stored at UNAVCO and shared
